FEEDING DIRECTIONS

Feed FARMERS BEST ALL PURPOSE SWEET FEED at the rate of one-quarter (0.25) to one pound (1.0) per 100 pounds of body weight per head daily. Vary amounts fed according to degree of body condition and/or performance desired. Provide ample amounts of good quality roughage, and fresh clean water at all times. Feed GILBERT'S MINERALS free-choice. For selenium purposes, this product should not exceed 75% of total ration.

CAUTION: Follow label directions. Feeding added selenium at levels in excess of 0.3 ppm in the total diet is prohibited.

WARNING! DO NOT FEED TO SHEEP. This feed contains added copper at levels that may be toxic to sheep.

REMINDER: Feed is perishable. Store this product in a cool, dry area away from insects. DO NOT feed moldy or insect-infested feed.
