FEEDING DIRECTIONS

Feed continuously as a complete feed at a rate of 1.0 to 4.5 lbs per head daily, to supply no less than 15 mg nor more than 70 mg Lasalocid per head daily depending on body weight.

CAUTION: The safety of lasalocid in unapproved species has not been established. Do not allow horses or other equines access to feeds containing lasolocid as ingestion may be fatal.

REMINDER: Feed is perishable. Store this product in a cool, dry area away from insects. DO NOT feed moldy or insect-infested feed.
