FEEDING DIRECTIONS

Feed continuously as a complete feed at a rate of 1.0 to 4.5 lbs per head daily, to supply no less than 15 mg nor more than 70 mg Lasalocid per head daily depending on body weight. For selenium purposes, this product should not exceed 50.85% of total ration.

CAUTION: The safety of lasalocid in unapproved species has not been established. Do not allow horses or other equines access to feeds containing lasolocid as ingestion may be fatal.

CAUTION: Follow label directions. Feeding added selenium at levels in excess of 0.3 ppm in the total diet is prohibited.

REMINDER: Feed is perishable. Store this product in a cool, dry area away from insects. DO NOT feed moldy or insect-infested feed.
