FEEDING DIRECTIONS

Self-feed FARMERS BEST CALF GROWER from weaning until calves have reached a body weight of 300 to 400 pounds. Limit intake to five (5) pounds per head daily. Provide good quality hay and a continuous supply of fresh, clean water. Provide salt free-choice. Feed GILBERTS MINERALS free-choice.

CAUTION: Follow label directions. Feeding added selenium at levels in excess of 0.3 ppm (54.55% of this ration) in the total diet is prohibited.

WARNING! DO NOT FEED TO SHEEP. This feed contains added copper at levels that may be toxic to sheep.
