## FEEDING DIRECTIONS

Feed MEAT GOAT COMPLETE PELLETT to goats from weaning to market weight. Can be fed to appetite or vary amounts fed depending on the rate of gain and body condition desired. Provide ample amounts of fresh, clean water at all times. For selenium purposes, this product should not exceed 71.4% of total ration.

**CAUTION:** Follow label directions. Feeding added selenium at levels in excess of 0.3 ppm in the total diet is prohibited.

**WARNING!** DO NOT FEED TO SHEEP. This feed contains added copper at levels that may be toxic to sheep.

**REMINDER:** Feed is perishable. Store this product in a cool, dry area away from insects. DO NOT feed moldy or insect-infested feed.
