FEEDING DIRECTIONS

Feed FARMERS BEST PB PIG MAINTENANCE PELLETS in controlled amounts divided into two equal feedings per day. Vary amounts depending on growth and or body condition desired. Amounts fed should range from 3-5% of body weight per day. Provide a draft - free, clean, dry pen with adequate space. Provide a continous supply of fresh, clean water.

WARNING! DO NOT FEED TO SHEEP. This feed contains added copper at levels that may be toxic to sheep.

REMINDER: Feed is perishable. Store this product in a cool, dry area away from insects. DO NOT feed moldy or insect-infested feed.
