### FEEDING DIRECTIONS

**SOWS IN GESTATION:** Feed as the sole ration. Feed 4 to 6 pounds per head per day depending on body condition, but do not feed to fatness. During cold weather, feed at the higher level increase intake 1 to 2 pounds per head per day the last 3 to 5 weeks of gestation to maintain body condition.

**SOWS IN LACTATION:** Feed as the sole ration. Intake will vary from 11 to 15 pounds per head per day depending on sow size and milk production.

Provide a continuous supply of fresh, clean water at all times.

**WARNING! DO NOT FEED TO SHEEP.** This feed contains added copper at levels that may be toxic to sheep.

**REMINDER:** Feed is perishable. Store this product in a cool, dry area away from insects. **DO NOT** feed moldy or insect-infested feed.
