FEEDING DIRECTIONS

Feed this product to goats continuously at 100% of total ration thus keeping a proper use level of Monensin at 20gm/ton.

Feed at a rate of 1 2/3 pounds per one hundred pounds of body weight per day to provide 18.15 mg Diflubenzuron per one hundred pounds of body weight per day (0.40 mg/kg of body weight/day).

REMINDER: Feed is perishable. Store this product in a cool, dry area away from insects. **DO NOT** feed moldy or insect-infested feed.
