For control of swine dysentery (bloody scours) associated with *Brachyspira hyodysenteriae* on premises with a history of swine dysentery but where signs of the disease have not yet occurred, or following an approved treatment of the disease condition.

CAUTION: Diagnosis should be confirmed by a veterinarian when results are not satisfactory. Feed containing an approved level of Bacitracin Methylene Disalicylate should be the sole ration. Not for use in swine weighing more than 250 lb.

WARNING! DO NOT FEED TO SHEEP. This feed contains added copper at levels that may be toxic to sheep.

FEEDING DIRECTIONS

Feed as a complete feed specifically formulated for pigs fed for exhibition. Start feeding when pigs weigh 60 pounds. It should be fed continuously as the sole ration until pigs reach market weight. Provide a continuous supply of fresh, clean water at all times.

This feed contains an insect growth regulator (Diflubenzuron), which prevents the development of house flies, stable flies and manure-breeding flies, specifically dark-eyed fruit flies, Phorid flies and drain flies, in the manure of treated swine. Feed as sole ration to ensure at least between 0.20-0.30 mg Diflubenzuron per kg of body weight per day.
